
Next, Mayor Langfelder asked for a motion to dispense with a reading of the minutes of the September 8, 2015 City Council meeting and approve the minutes. Alderman Redpath made the motion and Alderman Hanauer second. The motion passed on a voice vote of 10-0.

Next, Mayor Langfelder asked to incorporate the pre-council reading of the consent agenda into the record. Alderman Senor made the motion, with Alderman Donelan seconding the motion. Next, on the agenda is Ordinance 2015-304 is an ordinance authorizing execution of addendum C to the redevelopment agreement with Children's Museum Foundation Corporation to extend the date of completion of the project through September 30, 2016 and to increase the amount of reimbursable expenses by \$316,545.00 for a total amount not to exceed \$991,545.00 utilizing the City's Central Area Tax Increment Finance Funds. Alderman Redpath wanted to know if business would be grandfather in the liquor licenses and other permits. CC Zerkle said that the business' would have some grandfather rules would applied to building codes, but gaming and liquor licenses would have to be updated.

Eric Owen 400 Forest Avenue, Mr. Owen wanted to know why some addresses in Springfield Township were on the list and other weren't. Mr. Owen thinks that since The City hasn't spent the money the right way that they are closing the donut holes to fix the police and fire pensions. Mayor Langfelder entertained a motion to resume the regular City Council. Alderman Redpath made the motion to resume regular Council. There were multiple seconds. The motion passes 10-0 on a voice vote. Regular session of The City Council meeting resumed at 7:45 PM.

Next, Mayor Langfelder entertained a motion to suspend the rules and place 2015-341 on first reading. 2015-341 is an ordinance to increase the number of Class D liquor licenses by one for Springfield Char House Inc. doing business as Springfield Char House. Alderman Jobe made the motion to place the ordinance on first reading. Alderman Thelien seconded the motion. The motion passed on a voice vote of 9-0-1 with Alderman Fulgenzi voting present.

Next, Mayor Langfelder entertained a motion to suspend the rules and place 2015-342 on first reading. 2015-342 is an ordinance the execution of amended release agreement with Pinnacle Ltd. Partnership for property located at 700 East Adams Street used for Municipal Parking Garage. Alderman McMenamin made to motion to suspend the rules and place on first reading. Alderman Jobe seconded the motion. The motion passed on a voice vote of 10-0

Next, Mayor Langfelder entertained a motion to suspend the rules and place 2015-343 on first reading. 2015-343 is an ordinance amending Chapter 33, 37, 50, 51 and 52 of 1988 City of Springfield Code of Ordinance as amended relating to inter-fund transfer and finical polices. Alderman Jobe made the motion Alderman Donelan seconded the motion. The motion passes on a voice vote of 9-0.

Next, Alderman Thelien wanted to inform people about the United States Police K-9 Association public demonstration will be at Robin Robert's stadium from 7-8:30 pm also there will be the touch-a-truck going on as well, were kids can go climb and play on trucks.

Next, Alderman Turner wanted to thank everyone who came out supported the launch of "The Avenue North Grand Improvement Association" which was a huge success. This Thursday there will be a follow up planning meeting.

Next, citizens request to address the Council. Megan Golden from Ward 6, wanted to know if there will be a public forum about the Hunter Lake. Mayor Langfelder said that there will be open forum when the project moves forward.

Next, John Williams 1427 South College, he stated that he is concern about the future on CWLP and services both finally and environmentally. Mr. Williams gave Mayor Langfelder 90 sign petitions about citizens that share the same concerns.
