City Council Meeting
Tuesday, June 1, 2021
City Council Chambers**

PRE-COUNCIL SESSION

City Clerk Frank Lesko called the Pre Council Session of the Springfield City Council to Order on Tuesday, June 1, 2021 in the Council Chambers of the Municipal Center West.

CITY COUNCIL SESSION

Mayor Jim Langfelder called the June 1, 2021 meeting of the Springfield City Council to order at 5:30 PM. He invited everyone to recite the Pledge of Allegiance.

Clerk Lesko took the roll call of members.

Clerk Lesko announced there was a quorum for a meeting.

Roger Holmes, Inspector General, gave reports.

Director McCarty gave an updated budget presentation.

Next, Mayor Langfelder asked for a motion to dispense with a reading of the minutes of the May 18, 2021 City Council meeting and approve the minutes. Alderman Donelan made the motion to approve and Alderman Proctor seconded. The motion passed on a voice vote of 10-0.
