

AN ORDINANCE AUTHORIZING PURCHASE OF A USED GRAPPLE TRUCK FROM VARIOUS SELECTED VENDORS OR A COMPARABLE VENDOR FOR APEX EQUIPMENT AND SALES, INC. FOR AN AMOUNT NOT TO EXCEED \$290,000.00 \$303,910.00, FOR THE OFFICE OF PUBLIC WORKS, AS AMENDED

PROPOSED AMENDMENT NO. 1

WHEREAS, the City of Springfield is a home rule unit as defined in Article VII, Section 6(a) of the 1970 Illinois Constitution and has jurisdiction over matters pertaining to its government and affairs; and

WHEREAS, the Office of Public Works currently has three grapple trucks assigned to the Forestry Crew and desires to add another truck for backup since these units are often down for maintenance; and

WHEREAS, the City requested proposals pursuant to RFP #PW24-11-74 for a used grapple truck for the Office of Public Works; and

~~**WHEREAS**, the Office of Public Works would like to purchase a used grapple truck from one of the following vendors: (a) Schmidy's Machinery Co., (b) Custom Truck One Source, (c) Key Equipment Co. or (d) from a comparable vendor; and~~

WHEREAS, Apex Equipment and Sales, Inc. is willing to provide the City with a used grapple truck for an amount not to exceed \$303,910.00; and

~~**WHEREAS**, pursuant to requirements of Sections 38.38(a) and/or Section 38.41 of the Purchasing Code, the City Purchasing Agent has made a determination that it would be neither practical nor advantageous to the City to utilize the Sealed Competitive Bid process to obtain bids for this purchase; and~~

~~**WHEREAS**, a copy of suitable equipment from various vendors shall be on file in the Office of the City Clerk and attached to this ordinance.~~

WHEREAS, it is in best interest of the City to accept RFP #PW24-11-74 with Apex Equipment and Sales, Inc. and authorize payment in an amount not to exceed \$303,910.00 for a used grapple truck for the Office of Public Works; and

WHEREAS, a copy of RFP #PW24-11-74 is on file in the Office of the City Clerk.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SPRINGFIELD, ILLINOIS:

Section 1: That the City Council hereby authorizes purchase of a used grapple truck for the Office of Public Works for an amount not to exceed \$313,910.00 from Apex Equipment and Sales, Inc. The Mayor and City Clerk are authorized to execute any documents necessary to procure this equipment on behalf of the City of Springfield.

Section 2: That the Office of Budget and Management is hereby authorized to pay the selected vendor from account number 001-110-WORK-GARA-1504 upon satisfaction of provisions of the Purchasing Code.

Section 3: That this ordinance shall become effective immediately upon its passage and recording by the City Clerk.

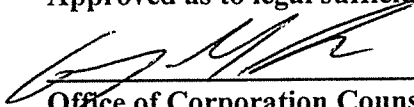
