WHEREAS, the City of Springfield is a home rule unit as defined in Article VII, Section 6(a) of the 1970 Illinois Constitution and has jurisdiction over matters pertaining to its government and affairs; and

WHEREAS, the City previously adopted ordinance number 073-03-22 authorizing the execution of RFP #PW22-24 for landscape waste collection services for a period of two years; and

WHEREAS, the end of the current contract is set to expire on March 31, 2024; and

~~**WHEREAS**, Republic Services is willing to renew the existing contract with the city of Springfield for residential landscape waste collection from April 1, 2024 through March 31, 2025; and~~

~~**WHEREAS**, Republic Services is not willing to renew the existing contract with the City of Springfield for residential landscape waste collection for a five-month term; and~~

~~**WHEREAS**, Waste Management of Illinois, Inc. is willing to provide residential landscape waste collection for the period of April 1, 2024 through August 31, 2024, for an amount not to exceed \$485,120.00; and~~

~~**WHEREAS**, the Corporate Authorities believe it is in the best interest of the City to waive all bidding requirements and enter into a contract with Waste Management of Illinois, Inc. for a five-month term beginning April 1, 2024 to ensure no service interruption for the citizens of Springfield.~~

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SPRINGFIELD, ILLINOIS:

Section 1: That the City Council hereby authorizes a five-month contract with Waste Management of Illinois, Inc. for residential landscape waste collection from April 1, 2024, through August 31, 2024 for an amount not to exceed \$485,120.00, for the Office of Public Works. The Mayor and City Clerk are authorized to execute any necessary documents on behalf of the City.

~~one year renewal of RFP #PW22-24 with Republic Services, Inc. for residential landscape waste collection from April 1, 2024, through March 31, 2025 for an amount not to exceed \$1,164,290.00, for the Office of Public Works. The Mayor and City Clerk are authorized to execute any necessary documents on behalf of the City.~~

Section 2: That the Office of Budget and Management is hereby authorized to pay ~~Republic Services~~ Waste Management of Illinois, Inc. (OCAP7000OWAS5800) an amount not to exceed ~~\$1,164,290~~ \$485,120.00 as follows:

Section 3: That this ordinance shall become effective immediately upon its passage and recording by the City Clerk.
