AN ORDINANCE AUTHORIZING THE EXECUTION OF A SUBRECIPIENT AGREEMENT WITH HELPING HANDS OF SPRINGFIELD UTILIZING HOME INVESTMENT PARTNERSHIP PROGRAM, AMERICAN RESCUE PLAN ACT (ARPA) FUNDS FOR AN AMOUNT NOT TO EXCEED \$1,115,000.00 FOR SUPPORTIVE SERVICES, TBRA, OPERATING EXPENSES, AND CAPACITY BUILDING FROM JULY 1, 2025 THROUGH JUNE 30, 2027 FOR THE OFFICE OF PLANNING AND ECONOMIC DEVELOPMENT

Proposed Amendment #1 to 2025-233: This Amendment reduces Home ARPA fund allocation to Helping Hands, Inc. from \$1,115,000.00 to \$765,000.00 and authorizes an RFP to be issued to bid the remaining \$350,000.00 to local organizations with annual operating budgets of under \$500,000.

WHEREAS, the City of Springfield is a home rule unit as defined in Article VII, Section 6(a) of the 1970 Illinois Constitution and has jurisdiction over matters pertaining to its government and affairs; and

WHEREAS, it is in the best interest of the City of Springfield to authorize ARPA Sub-recipient Agreement with Helping Hands of Springfield for supportive services, TBRA, operating expenses and capacity building in the amount not to exceed \$1,115,000.00 \$765,000.00 utilizing the City's Home ARPA funds from July 1, 2025 through June 30, 2027; and

WHEREAS, it is in the best interest of the City to ensure that local organizations serve the unhoused and under-roused populations; and

WHEREAS, allocating \$350,000 to local organizations with operating budgets of under \$500,000 will expand equity, capacity building, and innovative service delivery in underserved areas of Springfield; and

WHEREAS, the Office of Planning and Economic Development has determined that the program described in the Sub-recipient Agreement with Helping Hands, Inc. involves appropriate expenditure of Home ARPA funds pursuant to 24 CFR 570.201(c), Public Facilities & Improvements; and

WHEREAS, the Office of Planning and Economic Development shall issue a Request for Proposal to ensure that the local organizations described herein are operating programs that involve the appropriate expenditure of Home ARPA funds; and

WHEREAS, the ARPA Sub-recipient Agreement with Helping Hands, Inc. and with any other subrecipients; will be administered by the Office of Planning and Economic Development; and

WHEREAS, the proposed Subrecipient Agreement(s) described herein shall be located in the Office of the City Clerk.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SPRINGFIELD, ILLINOIS:

That the Office of Budget and Management is hereby authorized to make payment in an amount not to exceed \$1,115,000765,000.00 to Helping Hands of Springfield from account number 001-111-DEVL-HARP-2110 pursuant to the terms and conditions of Sub-recipient Agreement.

That the Office of Planning and Economic Development is hereby directed to issue a Request for Proposals, in coordination with the Office of Budget and Management, for locally operated organizations with annual operating budgets under \$500,000 that can meet the federal requirements for receipt and expenditure of Home ARPA funds.

That this ordinance shall become effective immediately upon its passage and Section 34: recording by the City Clerk.
